13. How competitions are generally drawn or judged

- 13.1. As many of you know, there are two main ways to enter and win competitions, and these are by chance, or by skill. Both have entirely different methods of drawing or judging.
- 13.2. If you need to know how the competitions to third party sites are drawn or judged, please enquire via the contact details on the specific site provided for the specific competition.
- 13.3. Chance competitions are usually drawn at random, and the method by which this is done varies. With mail entries, the old barrel draw method can still apply, however you would understand that no barrel exists to take the large amount of entries in some competitions. Often a culling process is used, by which a pile out of say 20 piles is randomly selected to be the final draw. Of course, this is totally at random and the process closely controlled. Survey based competitions/promotions would fall under chance competitions as you are entered regardless of your options in your survey.
- 13.3. SMS, web and phone can technically be drawn electronically. For a promoter to draw electronically, they usually need to comply with various tests to ensure that the computer systems are fair and equitable. In a large number of cases, these competitions are drawn manually.
- 13.4. Skills competitions (words-or-less for example) in particular are by law required to be judged on their merit according to the skills required and the competition/promotion rules.
- 13.5. Electronic skills competitions have made for an easier judging process. There are ways and means, perfectly legal and ethical for a company to search for certain criteria and narrow down the field.
